Prior to the initial pre-trial hearing, counsel for represented parties and all unrepresented parties that have appeared in this adversary proceeding are jointly responsible for arranging a conference to discuss the nature and basis of their claims and defenses and the possibilities for a prompt settlement or resolution of the adversary proceeding, and to develop a proposed discovery plan. Following the conference, Plaintiff's counsel shall complete and submit a Pre-Trial Worksheet that contains, at a minimum, the information requested below, to the Court at MSS-Pretrials@ohnb.uscourts.gov by not later than 12:00 p.m. on the day preceding the initial pre-trial hearing. Plaintiff's counsel shall assure that all counsel of record and unrepresented parties have received a copy of the Pre-Trial Worksheet.

The Court urges counsel to be efficient as possible in the administration and prosecution of this adversary proceeding. To that end, the Court permits and encourages telephonic participation in pre-trial conferences, unless ordered otherwise.

Stipulations: At the close of discovery, the Court requires counsel to jointly file a list of all matters which are not in dispute in this case and which can be the subject of stipulations, including any documentary evidence upon which the parties intend to rely in prosecution of their respective cases. Plaintiff's counsel shall draft an initial set of proposed stipulations and submit them to

Defendant's counsel for review and approval. Defendant's counsel shall incorporate any additional stipulations as appropriate for review and approval by Plaintiff's counsel. Counsel shall then jointly file the stipulations in the case approximately two weeks after the close of discovery.

Alternative Dispute Resolution: The Court supports counsel's efforts to resolve matters through the use of alternative dispute resolution. If all parties to the adversary proceeding are interested in pursuing some form of alternative dispute resolution, counsel shall jointly contact Judge Shea-Stonum's chambers to assist in that process. The Court will not order mediation at the request of one party in an adversary proceeding.

Miscellaneous: At the initial pre-trial hearing, counsel shall be prepared to:

- 1. Dismiss unnecessary parties;
- 2. Stipulate to facts and genuineness of documents and other exhibits not in dispute; and
- 3. Fully explore and be authorized to conclude settlement.
