### **MEMORANDUM**

To: All Canton Bankruptcy Practitioners

Date: August 31, 2009

Re: New Chapter 13 Confirmation Procedure in Canton

Recent failures of attorneys to provide information to the chapter 13 trustee have made it impossible for court staff to adequately prepare for confirmation. There have been too many cases remaining contested due to failure to provide the trustee with information requested at the 341 meeting, such as pay stubs, tax returns, dependency information and the like. Court staff cannot prepare for the number of cases listed as contested due to failure to follow up on simple matters.

Confirmation procedures will be changed immediately as a result. Trustee is to provide debtors' attorneys with a written request for information at conclusion of the 341 meeting. If trustee has not received the information fourteen days prior to the confirmation date set forth in the Notice of Chapter 13 Bankruptcy Case, Meeting of Creditors, & Deadlines (the 341 notice), trustee will be required to file a *Notice of Noncompliance with Trustee Request*, a sample of which is attached to this memo and is marked as Exhibit A, any time between seven (7) and thirteen (13) days before confirmation. Following expiration of the confirmation objection deadline, the court will then provide notice that the confirmation hearing has been continued and will continue the deadline for trustee to object to confirmation, even if the documents are thereafter provided. *See* Exhibit B.

Thereafter, it will be debtors' attorney's responsibility to provide the information and serve notice of a new confirmation date, whether or not an amended plan is required, using a format similar to that on the attached Exhibit C. A new docket event has been created: Notices – Ntc of Conf Hrg & Ddl to Obj to Conf - Canton.

This procedure is to be used <u>only</u> when debtors fail to provide information. It is not to be used when issues are disputed. Disputed cases shall move forward for argument and disposition. Incomplete cases are to be continued.

Debtors are not defenseless to any trustee request for fear that confirmation will be delayed. Debtors will receive trustee's information request in writing at the conclusion of the 341 meeting when handed the minute sheet. If requests are believed to be inappropriate, counsel can immediately file an objection to that request and the court will expedite the matter upon counsel contacting the courtroom deputy and advising of the time considerations.
