ONLINE PAYMENTS

HOW TO PAY A FEE ELECTRONICALLY

Payment of court fees (including filing fees and installment payments, copies, etc.) may be paid online via Debit Card, PayPal, or ACH (electronic payment from a bank account). ****Credit cards are not accepted by our court's program.**

If you choose to pay from a checking or savings account (this process is referred to as “Automated Clearing House” or “ACH”), you will need to select an Account Type and enter the appropriate information for your account including:

- Financial institution routing number
- Checking or savings account number, and
- Re-enter account number to confirm

If you choose to pay via Debit Card, you will need to select the Debit option and enter the card payment information.

If you choose to pay via PayPal, you will need to log in to your account. (We do not accept pay later options.)

This **Online Payments** program is not available to authorized and registered CM/ECF filers - including attorneys, claimants, creditors, and other registered users - except as provided in the limited exceptions listed below:

- Requests for copies of documents
- Request for certified copies of documents
- Requests for record search
- Requests for exemplification

Authorized and registered CM/ECF filers must continue to make payment of court filing fees directly through CM/ECF at the time a case, document, and/or motion is filed with the court.

(Online Payments for non-registered users)

****For copies: Contact the Clerk's Office for total number of pages and to arrange for pick up of documents at a specific court location.**

Alternatively, you may mail a self-addressed stamped envelope to the court and have your copies mailed to you.

The [Online Payments](#) program cannot be used for Chapter 13 plan payments or other payments that are payable to a trustee. Those payments must be paid directly to a trustee.

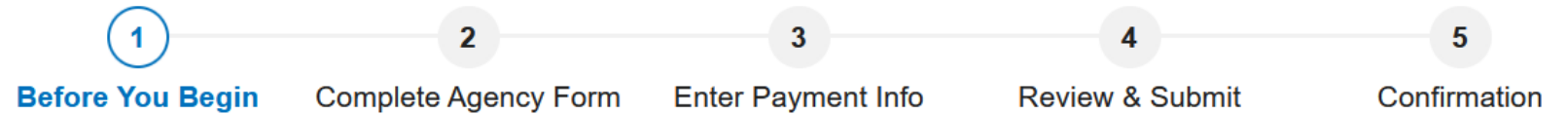


